CONDITIONS OF CONTRACTORS LICENSE - READ CAREFULLY

All-Pro Racing Series and/or their designee granting to me a license to participate in sanctioned events, and to compete for prize money or other remunerations, or to enjoy participation in scheduled sporting events, I hereby grant to said All-Pro Racing Series, et al, and/or their designee:

1- All fees, salaries, or other remuneration including residuals derived from any movie films, television, radio, advertising, or other entertainment media derived from my activities as a participant in any All-Pro Racing Series.

2- The right to publish, sell, advertise or use, in any fashion whatever, photographic, artistic, or other representations of me and/or my equipment, without remuneration nor advance notice to me.

3- A complete and unconditional release on behalf of myself and heirs for any injuries sustained by me while participating in any sanctioned event, or any damage to my property sustained while participating in any sanctioned event. As a condition under which All-Pro Racing Series agrees to issue to me a license to participate in sanctioned events, I affirm the following representations:

A- My participation in any sanctioned event shall be on a voluntary basis, in which event I shall be acting solely for myself as an Independent Contractor. I will not act as an agent, servant or employee of All-Pro Racing Series or any other person or organization if I participate in any event.

B- If, as a result of my voluntary participation in any sanctioned event, win any prize money or receive other remunerations, I do so as an Independent Contractor, and will maintain all necessary records and make all necessary tax returns.

C- Acting solely on my behalf as an Independent Contractor, I recognize the fact that All-Pro Racing Series does not provide Workman's Compensation Insurance, Unemployment Insurance, Unemployment Disability Insurance, Federal Old-Age Survivors Insurance, or any State or Taxes.

D-As a voluntary participant in any sanctioned event, I fully recognize the possibility of injury to my person and damage to my property, and I freely assume this risk as a participant in any sanctioned event.

E- I acknowledge receiving and reading rules and/or procedures for my class and I agree to abide by all rules and regulations contained therein.

4- I hereby authorize All-Pro Racing Series to arrange on my behalf insurance coverage in effect at any time of any All-Pro Racing Series sanctioned event. I recognize that All-Pro Racing Series has no obligation to provide such coverage, and any such coverage obtained shall be effective only if notice of loss is filed immediately after occurrence and designated hospitals and physicians are used. This coverage shall begin when I enter the pit on the day of a sanctioned event and terminate when I leave the pit on the day of the sanctioned event. I further agree not to litigate any matter between myself, agents or heirs and Glad Enterprises, Inc. or All-Pro racing Series or their designee.

5- I have read and understand this application for a participant's license. I fully understand the application contains a general release to all persons in any way connected with a sanctioned event, of for any personal injuries I sustain or any damage to my property.

6- Drivers and pit crew must be 16 years of age or older, with a valid California (photo) drivers license. Drivers or pit crew under 18 years of age must have a notarized parent or legal guardian

NO ONE UNDER THE AGE OF 16 YEARS OLD IS ALLOWED IN THE PIT AREA AT ANY TIME.
MANAGEMENT RESERVES THE RIGHT TO REFUSE ENTRANCE TO ANYONE.

I HAVE READ AND FULLY UNDERSTAND THE WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT AND I KNOW AND UNDERSTAND THAT MY SIGNATURE ON THIS FORM OPERATES AS A COMPLETE RELEASE OF ALL-PRO RACING SERIES, TOGETHER WITH IT'S OFFICERS, DIRECTORS, OFFICIALS, REPRESENTATIVES, AND AGENTS FROM ANY AND ALL LIABILITY, INCLUDING NEGLIGENCE, AND I FREELY AND WILLINGLY CONSENT TO THIS WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT.
